UPON DEPARTURE I UNDERSTAND THAT I MAY BE CHARGED FOR: MY REMAINING PHONE BILL, OUTSTANDING STORE TAB, SITE, AMENITIES, CLEAN UP OF SITE, MISSING UNIFORMS, MISSING LAUNDRY COINS, AND KEYS NOT TURNED IN (INCLUDING THE COST OF LOCK REPLACEMENT). CAMP GULF WILL NOT ABSORB ANY COST FOR MAIL FORWARDING. YOU MUST TAKE THE RESPONSIBILITY TO HAVE YOUR MAIL FORWARDED, AND LEAVE AN ACCURATE FORWARDING ADDRESS UPON DEPARTURE.
